

## NOTICE TO BIDDERS

Sealed Proposals invited by the Massapequa Water District (MWD) will be received by the Board of Commissioners, of the Massapequa Water District, in the District Office, 84 Grand Avenue, Massapequa, New York on **Wednesday, December 12, 2012** until **9:15 A.M.**, at which time the proposals will be publicly opened and read aloud at said place, for:

### MASSAPEQUA WATER DISTRICT BROOKLYN AVENUE SITE WORK MASSAPEQUA, NEW YORK

**Contract No. 1266622**

This contract consists of the removal of all asphalt from the parking/driving areas of the Massapequa Water District's Brooklyn Avenue Site. Also included within this Project is the installation of full depth asphalt pavement and an asphalt pavement overlay system; removal and replacement of the existing chain link fence, gates and motorized operators; installation of additional chain link fencing as required; installation/construction of a concrete storage bin; and lighting all as depicted on the construction drawings and as stated in the technical specifications. The contractors will furnish all labor, and furnish and install all materials and equipment required to complete the work.

Instructions to Bidders, Proposal, Supplemental Bid Forms, Form of Agreement, General Conditions, Specifications and the Plans, herein called the "Contract Documents", may be examined at the District Office from **9:15 A.M., November 26, 2012** until **3:30 P.M. on December 11, 2012**, Mondays to Fridays. Copies of the Contract Documents will be available at that time and place indicated.

A fee of **\$100.00** by check or money order, payable to the Massapequa Water District, will be required for each set of the Contract Documents requested. Prospective bidders requesting contract documents by mail must remit an additional, non-refundable, fee of **\$30.00** per set, to cover handling and first class mailing. For those Bidders that submit a proper proposal per these documents, and are not successful, and return the contract documents to the MWD in usable good condition within 30 days following the award of the contract; the full amount of the fee will be returned for the first set of contract documents. No refund will be made to non-bidders or for contract documents beyond the first set.

Wages and supplements payable to all laborers, workmen, and mechanics on this project shall be paid at the prevailing rates established under the New York State Labor Law.

**NOTE: THERE WILL BE A MANDATORY SITE INSPECTION ON THURSDAY DECEMBER 6, 2012 AT 10:00 AM, AT MASSAPEQUA WATER DISTRICT OFFICE. THIS WILL BE THE ONLY CHANCE TO INSPECT THE SITE. THE DISTRICT WILL NOT ACCEPT VISITS TO THE SITE AT ANY OTHER TIME.**
