

NOTICE TO BIDDERS

Sealed Proposals invited by the Massapequa Water District (MWD) will be received by the Board of Commissioners, of the Massapequa Water District, in the District Office, 84 Grand Avenue, Massapequa, New York on **Wednesday, January 3, 2018** until **5:30 P.M.**, at which time the proposals will be publicly opened and read aloud at said place, for:

MASSAPEQUA WATER DISTRICT**NEWF IRON REMOVAL FACILITY****Contract No. 11566631C-R ELECTRICAL WORK - REBID**

This contract consists of the electrical work for the installation of a new iron removal facility at Massapequa Water District's Northeast Well Field Site. Also included within this Project is the construction of a new building for housing the iron removal facility; construction of an underground equalization tank; removal and replacement of the existing caustic tanks; appurtenant piping for connection from Well No. 3 and Well No. 8 to the iron removal facility and into the distribution system; upgraded security system; and appurtenant instrumentation and controls as depicted on the construction drawings and as stated in the technical specifications. The contractor will furnish all labor, and furnish and install all materials and equipment required to complete the electrical work as indicated in the contract documents. The General Construction and Mechanical Contracts have already been awarded.

Instructions to Bidders, Proposal, Supplemental Bid Forms, Form of Agreement, General Conditions, Specifications and the Plans, herein called the "Contract Documents", may be examined at the District Office from **11 A.M., December 7, 2017** until **3:30 P.M. on January 2, 2018**, Mondays to Fridays. Copies of the Contract Documents will be available at that time and place indicated.

A fee of **\$100.00** by check or money order, payable to the Massapequa Water District, will be required for each set of the Contract Documents requested. Prospective bidders requesting contract documents by mail must remit an additional, non-refundable, fee of **\$30.00** per set, to cover handling and first class mailing. For those Bidders that submit a proper proposal per these documents, and are not successful, and return the contract documents to the MWD in usable good condition within 30 days following the award of the contract; the full amount of the fee will be returned for the first set of contract documents. No refund will be made to non-bidders or for contract documents beyond the first set.

Wages and supplements payable to all laborers, workmen, and mechanics on this project shall be paid at the prevailing rates established under the New York State Labor Law.

NOTE: THERE WILL BE A MANDATORY SITE INSPECTION AT 10:00 AM ON DECEMBER 15, 2017 AT NORTHEAST WELL FIELD AT OCEAN AVE & MARYLAND AVE IN MASSAPEQUA PARK FOR ANY BIDDER WHO DID NOT ATTEND THE EARLIER SITE MEETING (ON OCTOBER 18, 2017). THIS WILL BE THE ONLY CHANCE TO INSPECT THE SITE.
