Sealed Bids for DWSRF Contract No. 18510 – Intermunicipal Water Infrastructure Grant Program 2020 Water Main Replacements will be received by the Massapequa Water District office, located at 84 Grand Avenue, Massapequa, New York, until 4 p.m. (Local Time), on Wednesday May 5, 2021, and then at said office publicly opened and read aloud.

This Contract generally consists of utilizing a minimum of 2 crews working simultaneously to perform water main installation, hydrant replacements, water service improvements, and site restoration throughout the project area. This Contract will be primarily funded through a New York State Environmental Facilities Corporation (NYS EFC) Intermunicipal Water Infrastructure Grant (IMG) awarded to the Bethpage, Massapequa, and South Farmingdale Water Districts (OWNER's). All bidders will be required to meet all requirements for the grant, as detailed in the NYS EFC bid packet, including 24% Minority and Women-Owned Business Enterprise (MWBE) participation and 6% Service Disabled Veteran-Owned Business (SDVOB) participation. This work will be awarded to a single Contractor based on their overall total for all Districts as described in the bid sheets. Separate contracts will be signed between the Contractor and each individual OWNER, which includes separate bonds and insurances.

Each Bid must be accompanied by a certified or bank cashier's check made payable to each OWNER, or a Bid Bond issued by a surety licensed to conduct business in the state where the Project is located and having a Best Rating of A- or better from A.M. Best Company and named in the current list of "Companies Holding Certificates of Authority as Sureties on Federal Bonds and as Acceptable Reinsuring Companies" as published in Circular 570 (amended) by the Financial Management Service, Surety Bond Branch, U.S. Department of the Treasury, in an amount not less than five percent of the amount of the Bid submitted. Each Bidder must complete and submit with his/her bid the "Iranian Investment Activities Certification" provided in the Bid Form in compliance with General Municipal Law 103-g, Iranian Energy Sector Divestment.

Each Bidder must complete and submit with his/her Bid the "Certification of Compliance with New York State Labor Law Section Two Hundred One-G" provided in the Bid Form regarding the implementation of a written policy addressing sexual harassment prevention in the workplace.

The Bidder to whom the OWNER's propose to award the Contract will be required to furnish performance and payment bonds and the necessary insurance certificates as prescribed in the General Conditions and the Supplementary Conditions upon the execution of the Agreement.

Bidders are required to execute a non-collusive bidding certification required by Section 103-d of the General Municipal Law of the State of New York.

The attention of Bidders is particularly called to the requirements as to the conditions of employment to be observed and the minimum wage rates to be paid under the contracts.

Bidders are also required to comply with the anti-discrimination provisions of Sections 290-301 of the Executive Law of the State of New York.

The OWNER reserves the right to reject any or all of the Bids received, to readvertise for Bids, to abandon the project, to waive any or all informalities in any Bid received and to accept any proposal which the OWNER decides to be for the best interest of the OWNER.
